

## **ABSTRACT**

### **THE ROLE OF FIGHTING CRIME TEAM OF LAMPUNG REGIONAL POLICE IN MOTORCYCLE THEFT WITH VIOLENCE (Study on Regional Lampung Police)**

Lampung Police in order to follow up the crime of theft with violence against motor vehicle forming Fighting Crime Team is structurally under the Criminal Directorate General. Lampung Police task Fighting Crime Team is conducting the investigation activities and investigation of criminal offenses committed with violence, including the identification of the function and the function of forensic laboratories in the field of law enforcement, coordination and operational supervision in accordance with laws and regulations. The problems of this study are: (1) How Role Management Team Violent Crimes Lampung Police in dealing with the crime of motorcycle theft with violence? (2) What are the factors that hinder the role of the Violent Crime Reduction Team Lampung Police Lampung in addressing the crime of motorcycle theft with violence?

Approach problems using normative juridical approach and empirical jurisdiction. Speakers consisted of Lampung Police Investigator and Lecturer Criminal Law Section of the Faculty of Law, University of Lampung. Data were collected through library and field study. Data were analyzed qualitatively juridical

The results showed: (1) Role of Violent Crime Reduction Team Lampung Police Lampung in addressing the crime of motorcycle theft with violence are: a) Socialization of vigilance against criminal offenses of theft with violence, motor vehicle with banners appeal b) Placing Plainclothes members at vulnerable points of the crime of theft with violence, motor vehicle c) Implement enforcement through investigations and inquiries, the investigator attempts Lampung Police Fighting Crime Team in terms and in the manner stipulated in the law to search for and collect evidence with evidence that makes light of the crime of motor vehicle theft with violence that occur and to find the suspect. (2) The factors that hinder the role of the Violent Crime Reduction Team Lampung Police Lampung in dealing with criminal offenses motorcycle theft with violence consists of: a) Factors legal substance, namely the provision that under Article 183 of the Code of Criminal Procedure valid evidence is witness testimony, expert testimony, letters, instructions and information from the defendant, where the investigation may not be able to collect all the evidence The legitimate. b) Factors law enforcement officials, namely the investigation of potentially misusing discretionary powers, the lack of quantity and quality of police investigators. c) Factors infrastructure, the limited means of multimedia, wiretaps and police forensic laboratory in Lampung, so the investigation

is sometimes an obstacle. d) community factors, namely the lack of lawyers in assisting the accused who are undergoing investigation. e) Cultural factors, namely the persistence of a culture of compromise within the community as complete a criminal case.

Suggestions in this study were: (1) police personnel are advised to increase patrols in the framework of security and supervision of the locations that have the potential to be a place for offenders to commit crimes criminal offenses of theft with violence, motor vehicle (2) Control of the use of surveillance cameras media also should be improved so that in case of a crime of theft with violence criminal offenses of motor vehicles will be easier to identify.
