"The role is a behavior that is expected by others of a person who occupies a particular status and position" (Bruce J. Cohen, 1983: 76).

From the aspect of social reality is defined in terms of understanding the role of notch in fact fallen, so the role is defined as follows:

"The role is a subjective position that use of the rights and obligations to occupy a particular position" (Phil Astrid S. Susanto, 1985: 75).
