

## **ABSTRAK**

### **ANALISIS PENERAPAN *GOOD CORPORATE GOVERNANCE (GCG)* PADA PT ANGKASA PURA II**

Dalam satu dasawarsa terakhir ini *Good Corporate Governance (GCG)* mendapatkan perhatian luas setelah terjadinya berbagai /krisis seperti krisis moneter di Indonesia ataupun skandal Enron di Amerika Serikat. Prinsip-prinsip *Good Corporate Governance* (GCG), yaitu transparansi, akuntabilitas, pertanggungjawaban, kemandirian dan kewajaran baik dalam arti sempit dan luas. Dalam arti luas GCG berkaitan dengan para *stakeholders* perusahaan.

Data yang digunakan pada penelitian ini adalah data primer yang berasal dari kuesioner dan wawancara serta telaah dokumen. Jumlah sampel dalam penelitian ini adalah 95 responden. Data yang diperoleh kemudian diolah dengan metode analisis deskriptif.

Hasil penelitian menunjukkan bahwa secara keseluruhan, semua prinsip-prinsip *Good Corporate Governance* (GCG), yaitu transparansi, akuntabilitas, pertanggungjawaban, kemandirian dan kewajaran telah diterapkan dengan kategori baik pada PT Angkasa Pura II (Persero). Walaupun demikian, diantara prinsip-prinsip tersebut, penerapan prinsip transparansi memperoleh capaian penerapan tertinggi sedangkan prinsip akuntabilitas paling rendah capaian penerapannya.

## **ABSTRACT**

In the last decade this Good Corporate Governance (GCG) received widespread attention after the various/crises such as the financial crisis in Indonesia or the Enron scandal in the United States. Principles of Good Corporate Governance (GCG), namely transparency, accountability, responsibility, independence and fairness in both the narrow and broad. In a broad sense GCG associated with the company's stakeholders.

The data used in this study are primary data derived from questionnaires and interviews and review of documents. The number of samples in this study were 95 respondents. The data obtained are then processed by descriptive analysis method.

The results showed that overall, all the principles of Good Corporate Governance (GCG), namely transparency, accountability, responsibility, independence and fairness has been applied to both categories at PT Angkasa Pura II (Persero). However, among these principles, the principles of transparency obtain the highest achievements of the application of the principle of accountability while most low performance application.
