PENGATURAN PEMANFAATAN KAWASAN HUTAN LINDUNG UNTUK BUDIDAYA MELALUI HUTAN KEMASYARAKATAN (Studi Hutan Lindung Register 43B Pekon Sidodadi Kabupaten Lampung Barat)

Hutan kemasyarakatan merupakan hutan negara yang pemanfaatan utamanya diajukan untuk memberdayakan masyarakat. Berdasarkan surat keterangan Menteri Lingkungan Hidup dan Kehutanan No.SK.5957/MENLHK-PSKL/PSL.0/9/2018 Pekon Sidodadi mendapat Izin Usaha Pemanfaatan Hutan Kemasyarakatan (IUPHKm) seluas 2.057 Ha. izin diberikan kepada kelompok tani Wana Sidodadi Lestari..

Penelitian bertujuan untuk mengetahui (1) Bagaimana Pengaturan Pemanfaatan Kawasan Hutan Lindung Untuk Budidaya melalui Hutan Kemasyarkatan di Pekon Sidodadi Register 43B Kabupaten Lampung Barat, (2) Bagaimana Dampak Pemanfaatan Kawasan Hutan Lindung Untuk Budidaya Melalui Hutan Kemasyarakatan di Pekon Sidodadi Register 43B Kabupaten Lampung Barat. Metode penelitian yang digunakan metode yuridis normatif dan empiris, data yang digunakan primer dan sekunder, diperoleh dari studi kepustakaan dan lapangan, kemudian di analisis secara kualitatif, terkait rumusan masalah.

Hasil penelitian menunjukkan bahwa Pengaturan Pemanfaatan Hutan kawasan hutan lindung untuk budidaya melalui hutan kemasyarakatan (Studi Hutan Lindung Register 43B Pekon Sidodadi Kabupaten Lampung Barat) meliputi 3 aspek, pertama, kewenangan Pemanfaatan Hutan kawasan hutan lindung untuk budidaya melalui hutan kemasyarakatan berada pada Kementerian Lingkungan Hidup dan Kehutanan. kedua, Prosedur IUPHKm di Pekon Sidodadi meliputi; Permohonan yang diajukan oleh kelompok tani Wana Sidodadi Lestari, pengajuan permohonan diajukan secara langsung, kemudian dilakukan Verifikasi Administrasi dan Verifikasi Teknis, Setelah itu barulah diterbitkan IUPHKm. ketiga, dalam IUPHKm kelompok tani wana Sidodadi lestari dibebani hak dan kewajiban. Dampak IUPHKm meliputi: Kesejahteraan, Ekologi, SDM, Partisipatif, Kepastian Hukum.

ABSTRACT

REGULATION OF UTILIZATION OF PROTECTED FOREST AREAS FOR CULTURE THROUGH COMMUNITY FOREST (Study of Protection Forest Register 43B Pekon Sidodadi West Lampung Regency)

Community forestry is a state forest whose the main use is proposed to empower the community. Based on a statement from the Minister of Environment and Forestry No.SK.5957 / MENLHK-PSKL / PSL.0 / 9/2018 Pekon Sidodadi received a Business License for Utilization of Community Forestry (IUPHKm) covering an area of 2,057 hectares. The permission was given to the Wana Sidodadi Lestari farmer group.

This study is to find out (1) How the regulation of Utilization of Protected Forest Areas for Cultivation through Community Forests in Pekon Sidodadi Register 43B West Lampung Regency, (2) How the Impact of Utilization of Protected Forest Areas for Cultivation through Community Forestry in Pekon Sidodadi Register 43B West Lampung Regency. This research method used is normative juridical method and empirical, data used primary and secondary, obtained from literature studies and the field, then analyzed qualitatively, related to the formulation of the problem.

The results of the study show that the regulation of the use of forest in protected forest for cultivation through community forestry (Study of Protected Forest Register 43B Pekon Sidodadi West Lampung Regency) includes 3 aspects, first, the authority of Utilization Forests for protected forest areas for cultivation through community forests are at Ministry of Environment and Forestry. second, the IUPHKm Procedure in Pekon Sidodadi includes; Application submitted by Wana Sidodadi Lestari farmer group, submission of application submitted directly, then carried out verification Administration and Technical Verification, After that IUPHKm is issued. third, inside IUPHKm Wana Sidodadi farmer groups are endowed with rights and obligations. Impact IUPHKm includes: Welfare, Ecology, HR, Participatory, Legal Certainty.
