ANALISIS PERAN SENTRA PENEGAKAN HUKUM TERPADU (GAKKUMDU) DALAM PENANGGULANGAN TINDAK PIDANA PEMILIHAN KEPALA DAERAH (Studi Pada Provinsi Lampung)

Gakkumdu sebagai sentra penegakan hukum terpadu memiliki peran penting dalam penanganan pidana Pilkada.. Permasalahan penelitian adalah bagaimanakah peran Sentra Penegakan Hukum Terpadu (Gakkumdu) dalam penanggulangan tindak pidana pemilihan kepala daerah dan apakah faktor penghambat peran Sentra Penegakan Hukum Terpadu (Gakkumdu) dalam penanggulangan tindak pidana pemilihan kepala daerah.

Pendekatan masalah dilakukan secara yuridis empiris yaitu dengan melakukan penelitian langsung di lokasi penelitian dengan melihat, bertanya dan mendengar dari pihak-pihak yang terkait. Sumber data yang di dapat dengan menggunakan data primer dan data sekunder. Prosedur pengumpulan data dilakukan dengan cara studi kepustakaan dan penelitian lapangan. Analisis data dalam penelitian ini menggunakan analisis kualitatif.

Hasil penelitian menunjukkan peran Sentra Penegakan Hukum Terpadu (Gakkumdu) sebagai sentra penegakan hukum terpadu memiliki peran penting dalam penanganan tindak pidana Pilkada, dibentuknya Gakkumdu bermaksud untuk menyamakan pemahaman dan pola penanganan tindak pidana Pilkada oleh Bawaslu, Kepolisian Negara Republik Indonesia, dan Kejaksaan Agung Republik Indonesia. Para anggota Gakkumdu sendiri berasal dari Kepolisian Negara Republik Indonesia dan penuntut yang berasal dari Kejaksaan Agung Republik Indonesia. Faktor penghambat peran Sentra Penegakan Hukum Terpadu (Gakkumdu) dalam penanggulangan tindak pidana pemilihan kepala daerah, Sentra Gakkumdu sesungguhnya punya kewenangan untuk mengumpulkan dan mendalami bukti-bukti yang dibutuhkan maupun keterangan saksi sebelum laporan/temuan dugaan pelanggaran tindak pidana pemilu diteruskan kepada pihak kepolisian oleh lembaga Pengawas Pemilu. faktor penghambat yang paling menonjol pada peran Sentra Penegakan Hukum Terpadu (Gakkumdu) dalam penanggulangan tindak pidana pemilihan kepala daerah dari pihak masyarakat dimana masyarakat yang mengetahui adanya pelanggaran Pemilu tidak melaporkan ke Sentra Penegakan Hukum Terpadu (Gakkumdu).

ANALYSIS OF THE ROLE OF INTEGRATED LAW ENFORCEMENT CENTER (GAKKUMDU) IN MANAGEMENT OF CRIMINAL SELECTION OF REGIONAL HEAD SELECTION (Study in Lampung Province)

Gakkumdu as an integrated law enforcement center has an important role in handling the criminal election. The problem of research is how the role of the Integrated Law Enforcement Center (Gakkumdu) in handling criminal acts in the election of regional heads and whether the factors inhibiting the role of the Integrated Law Enforcement Center (Gakkumdu) in handling criminal acts regional head election.

The juridical empirical approach to the problem is to conduct research directly at the research location by seeing, asking and hearing from the parties concerned. Source of data obtained by using primary data and secondary data. Data collection procedures are carried out by means of literature study and field research. Data analysis in this study uses qualitative analysis.

The results showed the role of the Integrated Law Enforcement Center (Gakkumdu) as an integrated law enforcement center has an important role in handling criminal acts in the Pilkada, the formation of Gakkumdu intended to equalize the understanding and pattern of handling criminal acts by the Bawaslu, the National Police of the Republic of Indonesia, and the Attorney General's Office of the Republic of Indonesia . The Gakkumdu members themselves come from the Indonesian National Police and prosecutors from the Attorney General's Office of the Republic of Indonesia. Factors inhibiting the role of the Integrated Law Enforcement Center (Gakkumdu) in the handling of criminal acts in regional head elections, the Gakkumdu Center actually has the authority to collect and explore the necessary evidence and witness statements before reports / findings of alleged violations of election criminal acts are forwarded to the police by the agency Election Overseer. the most prominent inhibiting factor is the role of the Integrated Law Enforcement Center (Gakkumdu) in the handling of criminal acts in the election of regional heads from the community where people who are aware of election violations do not report to the Integrated Law Enforcement Center (Gakkumdu).

Suggestion, when talking about alleged violations of election crime then the hope is in the hands of the Gakkumdu Center, the Election Supervisory institution is only as an entry point, the analysis and subsequent decisions are on the shoulders of the Gakkumdu Center (Election Supervisory, Police and Attorney General) in their shoulders there is still hope a glimmer of hope for the enforcement of election crime in Indonesia to carry out a democratic party in the 2019 Presidential and Vice President elections.
