

## **ABSTRAK**

### **PENGAWASAN BADAN PENGAWAS PEMILIHAN UMUM PADA PEMILIHAN KEPALA DAERAH KOTA BANDAR LAMPUNG TAHUN 2020**

**(Analisis Pengawasan dalam Tahapan Pelaksanaan Kampanye,  
Pemungutan Suara, dan Rekapitulasi Hasil Penghitungan  
Suara di Tengah Pandemi Covid-19)**

Pemilihan kepala daerah tahun 2020 diselenggarakan pada 9 Desember 2020 di 270 daerah. Terdiri dari 9 provinsi, 224 kabupaten dan 37 kota salah satunya Kota Bandar Lampung yang telah melaksanakan Pilkada di tengah Pandemi Covid-19. Penelitian ini menggunakan penelitian deskriptif dengan pendekatan kualitatif agar mendapatkan deskripsi yang mendalam tentang pengawasan yang dilakukan oleh Bawaslu Kota Bandar Lampung pada Pilkada 2020 di tengah Pandemi Covid-19 tahapan kampanye, tahapan pemungutan suara, dan rekapitulasi hasil penghitungan suara. Penelitian ini dilakukan di Kantor Bawaslu Kota Bandar Lampung. Berdasarkan hasil penelitian yang dilakukan oleh peneliti dapat disimpulkan bahwa pengawasan yang dilakukan oleh Bawaslu Kota Bandar Lampung pada pilkada 2020 di tengah Pandemi Covid-19 pada tahapan kampanye tahapan pemungutan suara dan rekapitulasi hasil penghitungan suara yang telah dilaksanakan di Kota Bandar Lampung berhasil terlihat Bawaslu Kota Bandar Lampung telah melaksanakan pengawasan yang sesuai dengan prosedur dan mekanisme dalam aturan Pilkada 2020 di Tengah Pandemi Covid-19. Namun, masih terbatasnya Bawaslu Kota Bandar Lampung dalam menindaklanjuti dugaan pelanggaran *Money Politic* serta temuan yang tidak memenuhi syarat formil dan materiil sehingga harus melanjutkannya kepada lembaga yang lebih berwenang.

## **ABSTRACT**

### **SUPERVISION OF THE GENERAL ELECTION SUPERVISORY AGENCY IN THE ELECTION OF THE CITY OF BANDAR LAMPUNG REGIONAL HEAD IN 2020 (Analysis of Supervision in the Stages of Implementing the Voting Campaign and Recapitulation of Vote Count Results in the Mildst of the Covid-19 Pandemic)**

*The 2020 regional head elections will be held on 9 December 2020 in 270 regions. Consisting of 9 provinces, 224 regencies and 37 cities, one of which is Bandar Lampung City which has held elections in the midst of the Covid-19 Pandemic. This study uses descriptive research with a qualitative approach in order to get an in-depth description of the supervision carried out by the Bawaslu of Bandar Lampung City in the 2020 Pilkada in the midst of the Covid-19 Pandemic, the campaign stages, the voting stages, and the recapitulation of the vote count results. This research was conducted at the Bawaslu Office of Bandar Lampung City. Based on the results of research conducted by researchers, it can be concluded that the supervision carried out by the Bandar Lampung City Bawaslu in the 2020 elections in the midst of the Covid-19 pandemic at the campaign stage of the voting and recapitulation of vote counting results that had been carried out in Bandar Lampung City was successfully seen by the Bandar Lampung Bawaslu. Lampung has carried out supervision in accordance with the procedures and mechanisms in the 2020 regional elections in the midst of the Covid-19 pandemic. However, the Bandar Lampung City Bawaslu is still limited in following up on alleged violations of Money Politic and findings that do not meet the formal and material requirements so that they must be forwarded to a more competent institution.*
