(Comparative Studies on Three Villages in the Sekampung Udik Sub District East Lampung District)

BPD very important role in the determination of Perdes, during this often overlooked and less engaged by the village government. Almost all villages in Indonesia have set Perdes without involving BPD. APBDes a village regulation products containing sources of revenue and expenditure allocation village within one year. APBDes comprises part of village income, expenditure and financing village. APBDes draft discussed in village development planning. Village heads together BPD set each year by the regulatory APBDes desa. Berdasarkan observation and direct observation the author of three villages in the district of East Lampung District Sekampung Udik the Village Pugung Raharjo, Villages and Countryside Sidorejo Sindang Anom, indirectly, the authors observe that the difference BPD role to the three villages in setting Perdes APBDes. In the village Pugung Raharjo is a village that became a pilot, namely the maximum performance from the village head and BPD. While the other two villages namely Sindang Anom village and less cooperative Sidorejo between BPD and village head. The purpose of this study was to determine and analyze why the different roles Village Consultative Body (BPD) in the determination of the Village Regulations (Perdes) on Budget Village (APBDes) Pugungraharjo Village, Sindang Anom village and subdistrict Sekampung Udik Sidorejo Village East Lampung Regency .

This type of research used in this research is descriptive qualitative research. This study will focus on the different roles Village Consultative Body (BPD) in the determination of the Village Regulations (Perdes) on Budget Village (APBDes) Pugungraharjo Village, Village Sindang Anom and Sekampung Udik Sidorejo Village District of East Lampung District. Data processing is done by the selection of data, data classification, data preparation and data analysis.

The survey results revealed differences in the role that occurred from 3 villages which became the object of research. Of the three villages BPD Pugungraharjo Village is a village that has been very good in the preparation Perdes about APBDes, evidenced by the results of researchers down kedesas that Perdes

APBDes year 2013 has been designated by the government of the village with BPD, and the village of village government Sindang Anom less cooperation with BPD so Perdes APBDes already made by the head of the village without meeting with the BPD. While Sidorejo village between village government and BPDnya not mutually coordinated so that there has not been met for the determination Perdes about APBDes, so based on the results of research down to the village Sidorejo that there Perdes about APBDes of 2013 has not dibuat. Perbedaan-differences be explained in three villages can not be separated from the factors that influence it, especially the quality of cooperation between members of the BPD, the village head and the village community. BPD performance quality can not be separated from the village Pugungraharjo concern of all parties to the importance of preparation, a village to village development progress.

Advice, the village chief is expected to be more intensive Sidorejo present in the deliberations Raperdes about APBDes that BPD performance in preparing APBDes equal with the other two villages namely Pugungraharjo Village and Village Sindang Anom. Also expected to Sindang Anom village and village Sidorejo to increase the role of Village Consultative Body (BPD) in the determination of the Village Regulations (Perdes) On Budget And Shopping Village (APBDes) so it will be more orderly again administrasi in the village.
