Penelitian ini bertujuan untuk mengetahui: (1) Dampak sosial ekonomi masyarakat dibidang Pendidikan selama masa pandemi covid-19 di Tiyuh Mulya Kencana. (2) Dampak sosial ekonomi masyarakat dibidang pekerjaan selama masa pandemi covid-19 di Tiyuh Mulya Kencana. (3) Dampak sosial ekonomi masyarakat dibidang pendapatan masyarakat selama masa pandemi covid-19 di Tiyuh Mulya Kencana. Penelitian dalam penelitian ini menggunakan pendekatan kualitatif dengan metode deskriptif. Teknik analis data menggunakan teknik Analisis model Miles and Huberman.

Hasil penelitian ini menunjukkan bahwa: (1) Dampak positif pandemi covid-19 di Tiyuh Mulya Kencana yaitu adanya keikutsertaan walimurid, penggunaan teknologi dan jaringan, inovasi media pembelajaran dan pembelajaran jarak jauh. Sedangkan dampak negatifnya yaitu kesulitan memahami materi, siswa malas, penyalahgunaan handphone dan adanya keterbatasan penyelenggaraan daring. (2) Dampak positif dalam bidang pekerjaan yaitu masyarakat kreatif dan inovatif dalam menciptakan pekerjaan baru, penggunaan teknologi dan jaringan dalam melakukan pekerjaan, serta pekerjaan dapat dikerjakan dari jarak jauh. Sedangkan dampak negatif dibidang pekerjaan masyarakat yaitu masyarakat yang tidak dapat menggunakan teknologi hanya mengandalkan tenaga dalam memperoleh pekerjaan (3) Dampak positif pandemi covid-19 di bidang pendapatan masyarakat yaitu adanya peningkatan pendapatan masyarakat yang dapat memanfaatkan teknologi dan peningkatan pola fikir masyarakat dalam memperoleh pendapatan. Sedangkan dampak negatif dibidang pendapatan yaitu masih banyak masyarakat yang memiliki keterbatasan memperoleh pendapatan dan harga karet sebagai mata pencarian utama masyarakat di Tiyuh Mulya Kencana tidak stabil.

This study aims to determine: (1) The socio-economic impact of the community in the field of education during the COVID-19 pandemic in Tiyuh Mulya Kencana. (2) The socio-economic impact of the community in the field of work during the COVID-19 pandemic in Tiyuh Mulya Kencana. (3) The socio-economic impact of the community in the field of community income during the COVID-19 pandemic in Tiyuh Mulya Kencana. The research in this study used a qualitative approach with a descriptive method. The data analysis technique uses the Miles and Huberman model analysis technique.

The results of this study indicate that: (1) The positive impacts of the COVID-19 pandemic in Tiyuh Mulya Kencana are the participation of parents, the use of technology and networks, innovation of learning media and distance learning. While the negative impacts are difficulty understanding the material, lazy students, misuse of cellphones and the limitations of online administration. (2) The positive impact in the field of work is that the community is creative and innovative in creating new jobs, the use of technology and networks in doing work, and work can be done remotely. While the negative impact in the field of community work is that people who cannot use technology only rely on energy to get work. (3) The positive impact of the COVID-19 pandemic in the field of community income is an increase in people's incomes who can utilize technology and an increase in people's mindsets in obtaining income. Meanwhile, the negative impact in the income sector is that there are still many people who have limited income and the price of rubber as the main livelihood of the people in Tiyuh Mulya Kencana is unsTabel.
