

## ABSTRAK

Pemerintah melalui Keputusan Presiden Nomor 11 Tahun 2020 telah menetapkan Kedaruratan Kesehatan Masyarakat *Corona Virus Disease 2019* (COVID19) di Indonesia yang wajib dilakukan upaya penanggulangan sesuai dengan ketentuan peraturan perundang-undangan. Selain itu Presiden juga telah menetapkan Keputusan Presiden Nomor 12 Tahun 2020 tentang Penetapan Bencana Non-alam Penyebaran Covid-19 sebagai Bencana Nasional, yang menyatakan bahwa penanggulangan bencana nasional yang diakibatkan oleh penyebaran Covid-19 dilaksanakan oleh Gugus Tugas Percepatan Penanganan Covid-19 di daerah dan dalam menetapkan kebijakan di daerah masing-masing harus memperhatikan kebijakan Pemerintah Pusat. Oleh karena itu penegakan protokol di kantor Polisi juga harus sesuai dengan apa yang telah diatur dalam Keputusan Menteri dan Undang-Undang untuk memberikan contoh kepada masyarakat sekitar Kota Metro. Hal itu diharapkan akan mempengaruhi kondisi dan usaha yang telah dilakukan guna meminimalisir penyebaran rantai penularan Covid-19 dan juga sebagai contoh masyarakat untuk lebih taat dalam menjalankan Protokol Kesehatan sesuai aturan.

Penelitian ini bertujuan untuk mengetahui Implementasi Kebijakan Pencegahan Dan Pengendalian Corona Virus Disease 2019 (Covid-19) Di Polres Kota Metro. Adapun metode penelitian yang digunakan ialah dengan tipe peneliian deskriptif dengan pendekatan kualitatif. Pengumpulan data digunakan dengan teknik wawancara, observasi, dan dokumentasi. Hasil penelitian menunjukkan Polres Kota Metro sebagai Pelaksana kebijakan telah mengimplementasikan kebijakan sesuai dengan Standar Oprasioanl Prosedure (SOP). Hal ini sesuai dengan Model Implementasi Kebijakan menurut Van Metter dan Van Horn yang terdiri dari enam variabel yang mempengaruhi antara kebijakan dan kinerja pelaksanaan kebijakan. yaitu terdiri dari Sasaran dan tujuan, Karakteristik organisasi pelaksana Komunikasi antar organisasi dan aktifitas penguatan (interorganizational communication and enforcement activities) Sikap para pelaksana (disposition of implementors). Namun pada indikator Sumber daya, Polres Kota Metro belum dapat dikatakan terjalankan dengan baik dikarenakan kurangnya sarana dan prasarana yang mendukung berlangsungnya kegiatan pelaksanaan Kebijakan pencegahan dan pengendalian Covid-19 tersebut.

## **ABSTRACT**

*The government through Presidential Decree Number 11 of 2020 has determined the Corona Virus Disease 2019 (COVID19) Public Health Emergency in Indonesia which must be made efforts countermeasures in accordance with the provisions of laws and regulations. In addition, the President has also established Presidential Decree Number 12 of 2020 concerning the Determination of Non-natural Disasters of the Spread of Covid-19 as a National Disaster , which states that the management of national disasters caused by the spread of Covid-19 is carried out by the Task Force for the Acceleration of Covid-19 Handling in the regions and in determining policies in their respective regions must pay attention to the policies of the Central Government. Therefore the enforcement of protocols at the Police station must also be in accordance with what has been regulated in the The Minister's decision and the Act to set an example to the communities surrounding the Metro City. It is hoped that this will affect the conditions and efforts that have been made to minimize the spread of the Covid-19 transmission chain and also as an example of the community to be more obedient in carrying out health protocols according to the rules.*

*This research aims to determine the Implementation of Corona Virus Disease 2019 (Covid-19) Prevention and Control Policies at the Metro City Police . The research method used is a descriptive type of research with a qualitative approach. Data collection is used with interview, observation, and documentation techniques. The results of the study showed that the Metro City Police as the implementer of the policy had implemented the policy in accordance with the Standard Operating Procedures (SOP). This is in accordance with the Policy Implementation Model according to Van Metter and Van Horn which consists of six variables that influence between policy and policy implementation performance. i.e. consists of goals and objectives, characteristics of implementing organizations Interorganizational communication and enforcement activities) Disposition of implementors. However , in the Resource indicator , the Metro City Police cannot be said to be well implemented due to the lack of facilities and infrastructure that support the implementation of the Covid-19 prevention and control policy.*
