Bantuan Sosial yang memberikan kepada masyarakat sebenarnya bukan hal yang baru dilakukan oleh pemerintah. Program Bantuan Pangan Non Tunai (BPNT) adalah bantuan sosial pangan dalam bentuk non tunai dari pemerintah yang diberikan kepada Keluarga penerima manfaat (KPM) setiap bulannya. Kelurahan Kelapa Tiga Desa Kaliawi Tanjung Karang Pusat, merupakan salah satu daerah yang mendapatkan program bantuan non tunai (BPNT) dari pemerintah. Temuan peneliti terdapat kesenjangan dari penerimaan program bantuan non tunai tersebut, untuk itu penelitian ini bertujuan mendeskripsikan system pengawasan penyaluran program bantuan pangan non tunai (BPNT) di Kelurahan Kelapa Tiga. Penelitian ini menggunakan pendekatan kualitatif dimana peneliti memfokuskan pada system pengawasan yang dilakukan oleh dinas social kelapa tiga, teknik pengumpulan data melalui wawancara dan dokumentasi, dengan teknik reduksi data, penyampaian data, dan penarikan kesimpulan. Hasil penelitian system pengawasan dilaksanakan secara ketat dan terstruktur oleh pihak terkait, dalam system pengawasan dilakukan juga pelatihan bagi tim pengawas, survey dan evaluasi program serta melibatkan masyarakat dalam proses pengawasan.

Social assistance that provides to the community is actually not a new thing done by the government. The Non-Cash Food Assistance Programme (BPNT) is a non-cash food social assistance from the government that is given to beneficiary families (KPM) every month. Kelapa Tiga Village, Kaliawi Village, Tanjung Karang Pusat, is one of the areas that received a non-cash assistance programme (BPNT) from the government. Researchers found that there were gaps in the receipt of the non-cash assistance programme, so this study aims to describe the supervision system for the distribution of non-cash food assistance programmes (BPNT) in Kelapa Tiga Village. This research uses a qualitative approach where researchers focus on the supervision system carried out by the Kelapa Tiga social service, data collection techniques through interviews and documentation, with data reduction techniques, data presentation, and conclusion drawing. The results of the research supervision system are carried out strictly and structured by related parties, in the supervision system there is also training for the supervisory team, surveys and programme evaluations and involves the community in the supervision process.
