

## **ABSTRAK**

### **EFEKTIVITAS PERENCANAAN RENCANA INDUK KELITBANGAN (Studi Kasus Badan Penelitian dan Pengembangan Daerah Provinsi Lampung)**

Perencanaan Rencana Induk Kelitbang (RIRKD) Daerah Provinsi Lampung dalam mendukung pembangunan daerah yang berkelanjutan. Rencana Induk Kelitbang merupakan dokumen strategis yang menyelaraskan antara kebijakan pemerintah daerah dengan kebutuhan pembangunan penelitian dan pengembangan (litbang) di daerah tersebut. Dalam studi ini, digunakan pendekatan evaluasi melalui analisis deskriptif terhadap implementasi RIRKD serta kendala yang dihadapi dalam pencapaian tujuannya. Data dikumpulkan melalui wawancara dengan pemangku kebijakan, pengamat, dan pelaksana kegiatan kelitbang di Lampung, serta studi dokumentasi terkait perencanaan dan pelaksanaan program litbang.

Efektivitas perencanaan rencana induk kelitbang dirancang dengan memperhatikan kebutuhan daerah, efektivitas implementasinya masih terbatas. Faktor-faktor seperti kurangnya koordinasi antara lembaga terkait, minimnya sumber daya manusia yang kompeten, serta keterbatasan anggaran menjadi hambatan utama dalam pencapaian sasaran yang telah ditetapkan. Selain itu, sistem monitoring dan evaluasi yang belum optimal juga memengaruhi keberhasilan program tersebut. Oleh karena itu, penelitian ini merekomendasikan perlunya peningkatan koordinasi antar lembaga, penguatan kapasitas sumber daya manusia, serta perbaikan sistem pengawasan dan evaluasi untuk meningkatkan efektivitas perencanaan RIRKD di Provinsi Lampung.

## **ABSTRACT**

### **PLANNING EFFECTIVENESS OF THE LAMPUNG PROVINCE REGIONAL ALITIGHTS MASTER PLAN (case study of the regional research and development agency of Lampung province)**

Lampung Province Regional Research and Development Master Plan (RIRKD) planning to support sustainable regional development. The Research and Development Master Plan is a strategic document that aligns regional government policies with research and development (R&D) development needs in the area. In this study, an evaluation approach was used through descriptive analysis of the implementation of RIRKD and the obstacles faced in achieving its objectives. Data was collected through interviews with policy makers, observers and implementers of R&D activities in Lampung, as well as documentation studies related to planning and implementation of R&D programs.

The effectiveness of the research and development master plan was designed taking into account regional needs, the effectiveness of its implementation is still limited. Factors such as lack of coordination between related institutions, lack of competent human resources, and budget limitations are the main obstacles in achieving the set targets. Apart from that, the monitoring and evaluation system which is not yet optimal also affects the success of the program. Therefore, this research recommends the need to increase coordination between institutions, strengthen human resource capacity, and improve the monitoring and evaluation system to increase the effectiveness of RIRKD planning in Lampung Province.
