### **PENERAPAN PRINSIP *GOOD CORPORATE GOVERNANCE* PADA PERUSAHAAN BADAN USAHA MILIK NEGARA (Studi Kasus pada PT. Bukit Asam Bandar Lampung)**

Salah satu sistem terpenting dalam mengelola bisnis ialah tata kelola perusahaan yang baik. Tata kelola perusahaan atau *Good Corporate Governance* yang baik memastikan pertumbuhan, keberlanjutan, kesinambungan, dan integritas perusahaan. PT Bukit Asam Tbk, salah satu BUMN terkemuka di Indonesia, dituntut untuk memasukkan *Good Corporate Governance* dalam kerangka kerja operasional bisnisnya. Penelitian ini dilaksanakan agar mengeksplorasi dan menganalisis penerapan prinsip *Good Corporate Governance* di PT Bukit Asam Tbk, serta tantangan-tantangan yang dihadapi dalam penerapannya.

Penelitian ini menggunakan metode penelitian normatif empiris dengan jenis penelitian deskriptif. Pendekatan masalah yang dipergunakan dalam penelitian ini ialah pendekatan secara *life case study* yang berguna untuk mencari secara mendalam fenomena yang terjadi di lapangan. Sumber data didapatkan dengan dua cara yaitu melalui data primer seperti wawancara, dan data sekunder yang berupa buku – buku hukum, dokumen, serta tulisan ilmiah dan hasil penelitian yang berkenaan dengan topik ini. Semua data kemudian dianalisis secara kualitatif.

PT Bukit Asam Tbk sudah mengimplementasikan *Good Corporate Governance* secara efektif sesuai prinsipnya yang terdiri dari keterbukaan, akuntabilitas, tanggung jawab, kemandirian, dan kesetaraan, sesuai dengan hasil penelitian juga pembahasan. Rendahnya kesadaran karyawan terkait penerapan *Good Corporate Governance* menjadi penghambat dalam penerapannya di PT Bukit Asam Tbk. Upaya atau solusi yang dilaksanakan PT Bukit Asam Tbk antara lain dengan melaksanakan sosialisasi secara berkala dengan seluruh jajaran PT Bukit Asam Tbk.
