Penelitian ini bertujuan untuk mengetahui pengaruh *good corporate governance*, profitabilitas, ukuran perusahaan dan *leverage* terhadap *sustainable development goals*. Jenis penelitian yang digunakan adalah pendekatan kuantitatif dengan jenis penelitian asosiatif. Teknik pengambilan sampel pada penelitian ini menggunakan metode *purposive sampling* yang diperoleh 16 sampel dengan waktu pengamatan 7 tahun. Teknik analisis data yang digunakan yaitu analisis regresi data panel dengan bantuan *software* pengolah data yaitu E-Views 12. Hasil penelitian ini menunjukkan bahwa variabel *good corporate governance* dan *leverage* secara parsial berpengaruh signifikan terhadap *sustainable development goals*. Sedangkan variabel profitabilitas dan ukuran perusahaan secara parsial tidak berpengaruh signifikan terhadap *sustainable development goals*. Hasil penelitian ini secara simultan berpengaruh terhadap *sustainable development goals*.

This research aims to determine the influence of good corporate governance, profitability, company size and leverage on sustainable development goals. The type of research used is a quantitative approach with associative research. The sampling technique in this research used a purposive sampling method which obtained 16 samples with an observation period of 7 years. The data analysis technique used is panel data regression analysis with the help of data processing software, namely E-Views 12. The results of this research show that the variables of good corporate governance and leverage partially have a significant effect on sustainable development goals. Meanwhile, the variables profitability and company size partially do not have a significant effect on sustainable development goals. The results of this research simultaneously influence sustainable development goals.
